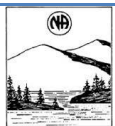
Regarding the Fund flow motion that failed – one group will not fund flow to ASC. Is there a way to find out what is being paid in bills so we can support that without supporting NAWS.

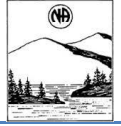
