The webpage is fully transitioned to Go Daddy. We are now investigating the best way to maintain current officer and subcommittee email addresses.



We will be hosting our next H&I subcommittee meeting on Saturday, March 30th due to the Easter Holiday.



Regional Committee Member Report February 25, 2024

Hello Everyone,

The ABCD Regional Service Committee met on Saturday, February 3rd at 11am with 4 of 7 Areas represented by their RCMs, RCM Alts, or a representative. This meeting occurs as a hybrid meeting. Anyone interested in attending Region please message me in the chat and I will get in touch with you.

There are open positions at Region (Helpline Chair, Hospitals & Institutions Chair, Policy Chair and Events & Activities Chair). If anyone is interested in any of these please reach out to me in the chat and I will get in touch with you to discuss.

A motion was made and voted on for the ABCD Region to fund the registration fee (\$25) for NESSSNA (Northeast States Service Symposium of NA) for two people from each of the 7 Areas that make up the ABCD Region. This motion passed. The impact is \$350 to the Region for this. NESSSNA will be held hybrid on April 26-28, 2024 at the Peabody Hotel in Boston, MA. A registration fee is required whether a ending in person or online. I have a ached the flyer to this event. And although the motion was not specific I am assuming the registration fee that ABCD is paying is for the RCM and RCM Alt. to a end. I will bring this up at the next RSC meeting for clarification. This event is hosted by the Northeast Zonal Forum.

Our Regional Delegate (Sandy Mc) proposed to adopt two project plans that came out of the ABCD Planning Session that was held last month on Zoom (report attached). The Green Mountain Area was asked if they would like to host a workshop that can piggyback onto another GMA event. The workshop would be called "How to make service more attractive". As your RCM I can only see one event that would be best suited for this and that would be Back to Basics campout. Perhaps we can discuss further to see if this is something this Area and Back to Basics are interested in or perhaps at another event.

There was a discussion brought up by an addict at Region regarding the ABCD meeting list. This was to remove the listing of virtual-only meetings from a town heading on the Regional mee ng list, and instead make a new heading called "Virtual Meetings" and then list those meetings there. The addict felt that by listing virtual meetings under a town heading was confusing and that this would make it simpler for addicts looking for a virtual meeting. This topic was carried to next RSC. There was an extensive discussion at Region this past month on how to increase attendance. One of the suggestions was to make Region an in-person only meeting. I brought up how the Green Mountain Area has been a virtual meeting since Covid and that we have no issues with attendance at our subcommittee meetins nor at our ASC meeting. I suggested that everyone at Region attend our meeting today to see how well virtual service meetings work. This topic will be carried and discussed some more at next RSC.


