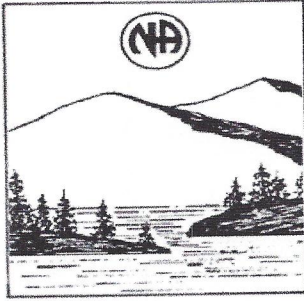
Updated BAB seed money in policy as per March
