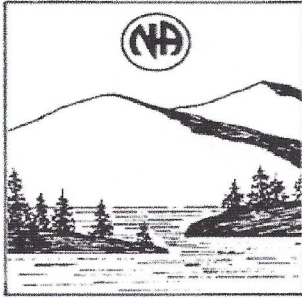

We met on Saturday, May 30, 2015 at 5:45 pm with 8 addicts in attendance.

- Cheshire County Correctional Facility – Men. Max has met his 1 year requirement out of the facility and will be getting in touch with Major Colby to determine next steps in order to re-activate this commitment.

Tammy, from the Upper Valley, was voted in to become a panel leader/member.

Tammy and Donna E. hope to service a facility in their area sometime soon.

Contact was made with Valley Vista. It appears at the moment that they are simply looking for NA speakers for a "12 Step" meeting that they already have established in the facility, rather than a formal H&I commitment. An offer was made to bring an H&I and PR presentation to the staff and was told that they would get back to us.

We are now going to follow up with Grafton County and see if we can meet a need there, more will be revealed.

We had discussion around the Phoenix House Dublin commitment regarding the necessity of our presence there any longer. Reasons for our discussion:

1. Upon arriving at the commitment this past week, an NA meeting format (reading "welcome to the Tuesday In House NA meeting) and laminated NA reading cards were found on the table. We are not saying that they shouldn't be doing this, In House meetings are great. It simply speaks to whether or not the presence of H&I is needed.
2. The number of clients has greatly reduced due to the majority choosing to attend an outside AA meeting instead, simply because they get to leave the property and be out with people in the community.

3. The clients do and have been able to attend the Thursday NA meeting in Marlborough, NH every week.

With the primary purpose of an H&I commitment being that we service facilities where clients/residents do not have access to outside meetings, the committee members feel that the resources of the committee may be better put to use elsewhere. I will be contacting the PHD facility.

We continued our work on the new PowerPoint Presentation for our Learning Days. Our goal is to make it informative, interesting and somewhat interactive...not simply a slide show we just sit and watch and call it a day. We want Learning Days to be something people look forward to attending and participating in. We are hopeful that the PP will be ready for the Learning Day at the Campout in August.

We decided to set up a secret **FB group** for H & I Subcommittee – Cheryl is willing to set this up. Admins will be Joanne, Max and Cheryl. Only H&I Subcommittee Members will have access to this page and any ‘invites’ will need to be pre-approved by one of the stated Admins. We will upload all H&I related material to this site so that all subcommittee members have one place to look for and find things. It will also act as a common place of communication between subcommittee members between subcommittee meetings.
