The sponsorship breakfast that was held in May brought in two hundred dollars with thirty addicts in attendance. It was a good morning with good recovery.

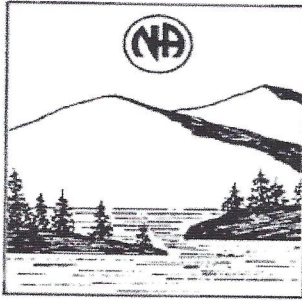

# Literature Subcommittee Report July 2015

The Literature Subcommittee policy practices the literature subcommittee guidelines and the N.A. Literature Committee handbook. We sell literature solely at area monthly meeting so come here to buy it because committee members are not supposed to sell it otherwise. We do not carry specialty items as listed in the monthly order form but we can order them for you. Normally we place our area purchase order to N.A. World Services every odd numbered month of the year. By doing this, we obtain merchandise at a lower price with less shipping expense, usually lower than ordering online by an individual or group ordering directly from World Services. Generally our price is 3% above cost from World Services. If a group needs a special item, or a medallion for an anniversary, please let the subcommittee know in advance, preferably 2 months, prepay, and we will order it for you. Please check your orders purchased at area when you get them because problems must be resolved before the end of of GMASC area meeting. Also, please use the newest version of the order form which is available from the literature table or online at the GMANA website.

At the July area meeting, \$261.20 of literature was sold.

We also inventoried our stock, we have \$2,236.59.
