We normally make an area purchase order from N.A. World Services every other month. By doing this, we get merchandise at a lower price with lower shipping costs. The result is addit dollar contributions stretch further towards buying literature, and we pay less for shipping. Also, our method results in lower cost than if an individual or group ordered online from World Services or a service center.

We do not carry the specialty items listed in the monthly order form. If a group needs a special item, or a medallion for an anniversary, tell the subcommittee two months in advance, prepay, and we will order for you.

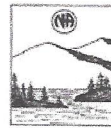

8+ addicts in attendance.

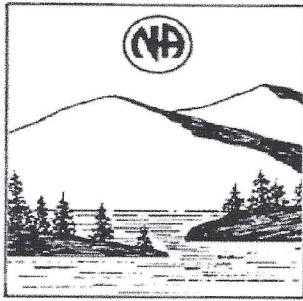
We continue to make efforts to update
