I am proud to announce that we are now a client of TD Bank! We have ~~not~~ opened a new bank account as we had some tax related complications. We resolved these issues by applying for a Non-Incorporated tax ~~the~~ entity number. The literature subcommittee follows the subcommittee guidelines and the N.A. Literature Committee Handbook. We can only sell literature at the GMASC monthly meeting, and typically make an area purchase order from N.A. World Services every other month. By doing this, we get merchandise at a lower price with lower shipping costs.

We don't carry the specialty items listed in the monthly order form. If a group needs a special item, or a medallion for an anniversary, tell the subcommittee two months in advance, prepay, and we will order it for you.

Please check your orders purchased at area when you get them because problems must be resolved before the end of GMASC area meeting.

A physical inventory of the literature stockpile was completed in accordance with the GMANA literature subcommittee guidelines, and the total value of literature on hand is \$1,756.16. The guidelines also state that the total value of funds and inventory may not exceed \$1,749.00, and that the "excess funds will be made available to GMASC for general expenses." Thus, the excess \$7.16 will be put into the general fund this month.
