**Motion/Intent:**

The PR Chair moves that the Green Mountain ASC adopt the following as policy under Article VII, Section 7.0:

All ASC Administrative Officers and Subcommittee Chairs will be provided an official @gmana.org email account. These trusted servants will use only the provided email account when

- Communicating with members of the public or RSC/WSC trusted servants on behalf of GMASC
- Registering for accounts on behalf of GMASC (such as web hosting accounts, bank accounts, etc).

The PR Chair further moves that the current content of Article VII be renumbered as appropriate to accommodate the new section.

The Intent of this motion is to ensure that the Green Mountain Area Service <sup>Committee</sup> Conference maintains access to it's associated accounts in the event that a trusted servant becomes unavailable. The PR subcommittee has tried to act as a single point of contact for ASC email communication, but this has proven unrealistic. The Website Guidelines for the PR subcommittee already requires that passwords be shared with the PR Chair. As our world continues to move in a direction where more and more communication & services are provided online, it's now important that this issue be addressed at the Area level as it relates to all Officers/Subcommittee Chairs – not just the Website Coordinator. Sharing passwords is not a real solution. Some reasons include:

- Users often use the same password for all their accounts – it would be unreasonable to ask them to disclose that password
- If a user resets their password (which will happen more often if they must use a password they're not familiar with), disclosing the new password each time becomes prone to error or simply forgetting.
- Disclosing a password at all implicitly weakens the security of that password.

Utilizing a service designed for organizations offers management tools that have solved these issues for countless groups & companies. These same tools would benefit GMASC.
