

Good morning:

## ABCDRNA Convention Committee Report June, 2016

With approximately two months remaining until the convention, things are moving along well. All of the workshop and main speakers have been confirmed and Workshop packets have been printed. We have secured taping and merchandise vendors. The logo has been selected and merchandise orders for the convention are underway. The artwork for the banner is being designed and we anticipate that being ready by the end of July. All of the DJ's are lined up for all upcoming events and the convention. The entertainment has been confirmed and plans are moving along at with the hotel. Pre-registrations continue to come in via mail and on-line registrations; we have sold 35/60 rooms for Friday night and 45/60 for Saturday. The hold on the block expires on July 27<sup>th</sup> but will be extended if need be.

The hotel has been taken care of. We anticipate being able to cover our remaining expenses with revenue from upcoming events. However, in the event that it is not advantageous to front the remaining balance of \$2,000, the hotel has agreed to forgo the last installment until the Monday following the convention. This provides adequate leeway in taking care of other expenses (i.e. merchandise, bags, lanyards, programs, etc.) before covering most of, if not all of, the remaining balance on the hotel.

We are working on finalizing plans for the opening, banquet and logistics regarding workshop and event locations. We have posted a request on our facebook page and we would appreciate if this could be mentioned throughout the region. During the convention we are planning a tribute to members who have passed away. The tribute will be a part of the opening night event.

Good morning:

A productive month for the Events Ad-Hoc, at least from those who participated in the decision making. Kudos to the MHA for their enthusiastic participation in those decisions.

In preparation for a conference call to put some of the efforts I was putting together out there, I sent a draft flyer and a menu from a potential caterer to contacts in our areas, those who wanted to participate and others that may better know who, in their areas, may be interested.

We scheduled and had a conference call on Tuesday, June 14<sup>th</sup> with Sal, Marc and I. Michelle was unable to participate as well as Don. They both gave me their confidence to move forward. We attempted to include Mary but she later explained that she was on her way home and did not have a cell phone signal.

We decided to go with the catered BBQ charging \$15 per person, for a ½ chicken BBQ with 2 sides and 1 drink, we will also sell sodas/water at the event. It is a fundraiser and all profits go to purchase IPs and Meeting Lists for our Areas, but the event is mainly to put forth unity among our region's areas. The ability to purchase tickets for newcomers or a more experienced member that lives on a fixed income is always present and welcome. I am getting advance tickets printed and I hope that they are done and in my possession at the RSC. It's been tricky with the perforated Avery tickets I purchased being used by Staples, Minute Man Press, etc. I will eat the cost of those tickets which are unusable except at a very high cost that would not be a prudent use of funds. I requested 100 tickets be prepared and hope that a specific member from each area will sell them. The caterer wishes to have the head count 2 weeks before event, we of course can continue to sell tickets but they need at least 50 sold in order to make it worth their while. We would only need to supply the drinks one to include in meal and the rest to sell. The caterer supplies all condiments, paper products, etc. This is meant to be a family fun filled day at Thacher Park, with fellowship, food and games, and perhaps a hike along the trail for those who wish to do so.

Days after the conference call, I was thinking that I always enjoyed the auction the Promise of Freedom Campout then ran it by other members who also seemed to think it was a good idea and suggested we start collecting items to be auctioned. A flyer will be created for that purpose hopefully using the same area members who sell the tickets as

the collectors. I also wondered if a quilt-could-be created to be auctioned off. I know Teri is a great quilter and I learned that another member from Mid Hudson also quilts. Then I thought that a Quilting Bee could be arranged for sometime in August to assist in teaching interested members how to do it, I have always wanted to learn. A quilt could be created using donated T shirts designed for our many events throughout our Region over the years. I have several that I would be willing to part with myself for this endeavor.
