ASC Treasury Officer Report September 2016

Last month we took in \$411.43. Literature sales were \$163.26 and group donations were \$248.17. The balance of our account is \$3,703.69.

I have sent out current budget expense reports to Literature, PI and H&I. If the officers could please review these reports and contact me with questions/changes. Thanks! I have a paper copy if anyone needs one.

I apologize that I gave you incorrect information last month during elections. To clarify, the Treasury guidelines state that the Vice-treasurer is a two year termed position. This means that Brittany will be standing treasurer and will continue to be mentored by Tex and myself. This will free me my treasurer responsibility significantly and I will consider availability to another area of ASC that is needed.

The ASC guidelines suggest a 2 year clean time requirement for ASC Treasurer. The Treasury guidelines suggest a 3 year clean time requirement and thus the ASC guidelines should be updated with this information. As Brittany meets the current ASC guideline but not the Treasury guideline and is already vice treasurer, this needs to be discussed.

As treasurer, I have seen immaculate performance and trust from Brittany. Since May of 2015, Brittany has been handling money with me. Since January of 2016, Brittany has had full access to the ASC funds and has shown professionalism and responsible ASC spending.
