Motion: The Regional Events & Activities Sub-committee shall fulfill its purpose by coordinating and pooling the local resources of the member Areas to enhance delivery of services by the Area E&A Sub-committees. It will encourage cooperation and coordination among the Area E&A Sub-committees by maintaining a calendar of scheduled events to avoid scheduling conflicts; maintaining communications through regular meetings (via Web, phone, or in person) to promote the exchange of ideas and information; and by assisting Area E&A Sub-committees in the planning, coordination and execution of local events for the purpose of promoting Regional unity. An annual budget of \$250 will be made available for discretionary spending. Additional requests for funding shall be subject to approval by the Regional Service Committee.

Intent: To define the role of the Regional Events & Activities Sub-Committee in coordinating and pooling the resources of the member Areas to enhance Fellowship unity, while avoiding duplication of services already provided at the Area level.

Cares and Concerns

H&I has a \$500 budget – Greg H asks if he needs to submit a motion to spend these funds? No, but a financial reporting should be submitted each month with the Officer's Report, to maintain a record of how funds are used.

Cecil asks if \$100 covers the needs of All Will Be Well, or will they need additional funding? Tammi says no, \$100 is plenty. They do, however, need a 16 year medallion, how can we get that? Does a group have one they can offer? Should we overnight one? Several groups offer to check their supplies, and Tammi indicates a willing to visit an out of town meeting to retrieve one.

Will expresses some concern that Activities will choose to hold their subcommittee meeting at the same time as other subcommittees. He's concerned that this will force addicts to choose which subcommittee to participate in. Pierre suggests that the Activities subcommittee joins the Campout subcommittee meeting, sharing a meeting time/location. General consensus is that the campout committee needs all the time it currently has to accomplish it's business. There's a similar concern about how PR is affected by offering time to H&I. Chris J offers that forcing addicts to choose is possibly good, as it prevents addicts from overextending themselves. Cecil adds that having the same opinions and personalities in each subcommittee could cause harm – having diversity among subcommittees is beneficial. Erika offered her personal experience moving through different committees each year to learn new things, and that she uses time outside of area to participate in other forms of service that she doesn't have time for during the ASC. Will mentions that Activities might be an exception to these wise suggestions, as it will coordinate group events that everyone may need to be involved with. He specifically cites his involvement in PR, but that he was involved with the group that put on the recent New Years Eve party.
