

Motion: To delete the last sentence in Regional Policy IV (B)(3) that currently reads, "No sales of meeting lists may be conducted outside

of the Regional Meeting" and replace it with the following language. "Ideally, meeting lists should be purchased at the Regional meeting, however, meeting lists may be sold outside of the regional meeting at the discretion of the Meeting List Coordinator."

Motion: To add to our Regional Policy, under Appendix A 2017, Section VII (H) Events and Activities Defined, the following:

- 1. The ABCD RSC Treasurer will maintain a revolving E&A Fund of \$500 separately from all other funds. No regional funds outside of the E&A Fund will be provided to E&A without discussion and approval by the ABCD RSC body.
- 2. This fund cannot be used for any other purpose except by a motion requiring a 2/3 vote.
- 3. All money brought back to the ABCD RSC by E&A will be applied directly to the E&A Fund until the balance is met. Anything over \$500 will be applied to the regional operating budget.
- 4. A bank deposit must be made by the person responsible for the E&A funds by the next business day after the end of the

Cares and Concerns

Should activities purchase a portable shade canopy? Discussion revolved around storage, liability, cost. Also, manpower and skill required to set it up.

Should PR or ASC purchase a laser printer? This has been discussed in the PR subcommittee, but there seems to be some interest that other subcommittees & ASC officers would benefit from access to laser printer. It would save significant money for PR, and would fit comfortably in our budget, but maybe it should be an area possession instead? Who would be responsible for the equipment? No real answers other than a suggestion to make a formal motion....

Someone has emailed us with their resume asking for a job – we are not a professional organization and don't offer internships.

Cecil notes that his meeting list app shows incorrect information. Discussion revolved around the variety of sources for meeting information – some we control, many we don't. Also mentioned were ongoing efforts to coordinate with Region & World Services (more to be revealed). Groups are also welcome to submit individual updates at http://www.na.org/?ID=updates. NAWS acknowledges their listings are often inaccurate, and encourages members to seek information on local sites (such as at http://gmana.org/meetings/).

Are we still stocking GSR Orientation Packets? Literature says they planning to have 4 printed. Two are already spoken for, maybe literature will print 6.

Motion to extend by Will S, seconded by Britney, 11-0-4

Ken S raised some concern about the clean time requirement for vice-chair being less than requirements for some positions they may be asked to fulfill. While discussing this, we became aware that Vice Chair has a suggested 1 year clean time requirement, and is supposed to be a cosigner on the ASC bank account. There was general agreement that this was inappropriate and should be addressed in a future motion.

Tammy has concern about the atmosphere of recovery and service, people are irritated, angry, contentious all day. Where's the love?

Britney draws attention to some potential confusion in areas like Keene about how to carry a group's conscience. How does my vote count if my home group doesn't carry a vote to ASC. Greg clarifies that you should only have one vote carried to area, and that we shouldn't be voting on ASC motions at multiple group business meetings. Lacy shares her experience with choosing to only vote at a single group. Bill T reminds us of the second tradition. Cecil says he found a solution in stepping up as GSR for his group. He suggests encouraging Area Service. Jackie offers that if being part of a group that participates in the NA service structure is important, we should choose our home groups with that in mind.

James plugs a GSR Learning Day. More will be revealed.
