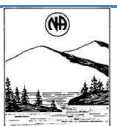

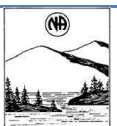
## Cares and Concerns

The issue with NAWS and our Literature Committee is RESOLVED!!!! *Clapping ensued!* Literature Chair spoke with Silvia from NAWS and with the help of the Area Treasurer, was able to resolve all the issues with the overdue payment issue – since we were not overdue. We never owed them any money.

- There was a miscommunication as to what order it was (2<sup>nd</sup> time this has happened). It was the same order that they originally claimed we had not paid for. Area Treasurer had proof that it was originally drafted right from ASC bank account. Literature Chair was confused as to what order NAWS was talking about because we never actually got any other order. Literature Chair and Silvia (NAWS) determined that the order in question was the original (only) order for which proof of payment had already been provided. We had to prove it again (second time).
- Literature Chair received an email from Silvia (NAWS) acknowledging that they had corrected it in their system, and we are all set.
- Literature Chair has saved the correspondence – 😊
- Question was posed as to whether the Literature Chair intended to now order from NAWS or to continue to order from Free State Region.
  - Unless directed otherwise, Chair intends to order from Free State because:
    - NAWS still does not accept the Green Mountain Area card in her name (primary reason)
    - Pricing and shipping are comparable when ordering from Free State Region, especially with smaller orders. Will continue to monitor shipping costs to ensure this remains the case.

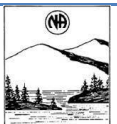
