

#### Cares and Concerns

Concern about how few meetings are sending representatives to Area, and those that are coming are mostly from the southeastern corridor of the area. Is anything being done to get more folks here?

- Historically, the holiday months are low November and December.
- We have reached out to meetings but cannot make them come.
- For a solid year, we provided the option of remote call-in, and only once did a group do that.
- PR Chair goes to a lot of meetings outside of his HG; the meetings that he attends sometimes have 3-4 members. These meetings are doing all they can to keep the meetings going; they don't have the officers to attend Area.
- Are there any ideas or suggestions to make Area more attractive to groups?
  - o Groups could send reports with someone who is going, so at least the groups would have representation and the reports could be included in the minutes.
  - There may not be GSR representation (so the rep could not vote), but our Area could be kept up to date on the goings on of the groups and they would be included (3)
- As previously mentioned, there is a phone line number and an email address on the meeting list.
  - o If there are any meeting members that are not able to attend ASC, give us a call or send an email and let us know how your group is doing.
- Could we in some way or another get an email address from a group member and then add them to the mailing list, so they at least know what is going on at the Area level.
