Cares and Concerns

Additional information regarding the Zoom platform's newly instituted security protocols for use of its services:

Zoom has been wanting to make things more secure for a long time. As such, Zoom has turned on, automatically, a feature that now requires every meeting have a waiting room. This means the host has to admit people to the meeting. There is the option to change this feature, but this requires that all meetings now have a password. Area Service will likely now have a password. PR did not want to make the decision for the groups that groups would have passwords vs. the waiting room.

The other option is to eliminate the waiting room and require a password. This would allow folks that want to join the meeting before the host to do that. The password would have to be shared with ppl that go the meeting. This information could be put up on the Area website. The website would be updated to have the most up-to-date information and if the link on the Area website is used, it will have the password embedded in the link.

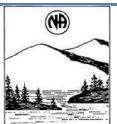

H & I Question – in the report, it was mentioned that the Vice Chair is trying to obtain H & I's files. What is that?
