The H&I subcommittee met last Sunday (18-April-2021) with four addicts in attendance. Our main points of discussion were attracting more members, communicating with other potential facilities that are interested in our services and the possibility of an H&I Learning Day.

Right now, we are still hosting only one H&I commitment within our Area. It is held at Live Free facility in Keene, NH. This meeting is hosted each Sunday at 1:00 pm. (when possible). Thank you to Chad B and Gary F. for their recent service during this past month!

Another residential facility in Keene (Prospect House) contacted me this past week about our availability to bring an NA meeting to them in person. They are flexible on the day and time, but I am hesitant to over-commit and try to host another meeting when it is still a challenge to maintain regular attendance in a meeting we already have. I would like to see the H&I Subcommittee have 2-3 more consistent members/panel leaders before we begin hosting another commitment.

The Phoenix house in Dublin, NH has also expressed interest in having us host an online Zoom meeting for them. However, they do not have visual capabilities, only audio. I don't feel that limited ability would work well for an H&I presentation if we cannot see the residents whatsoever. We are open to trying, but again, we need more committed members before we agree to host another meeting.
