Dear Green Mountain Area Family,

The ABCD Regional Service Meeting was held on Zoom on January 8th. It was immediately followed by the workshop "Decision Making in the ABCD Region Part 2" with a lot of discussion regarding how to streamline the voting process on Regional motions. Please see attached ABCD RDA Report for notes from that workshop.

- There were 5 motions on regional service positions that were up for voting but a vote could not be held due to lack of voting quorum. So they were tabled by to Areas which I am presenting today to be voted on at Area and I will bring our votes back to Region.
- Today, under cares and concerns, I will be proposing a workshop on the CAR (Conference Agenda Report issued by NA World Services) and a proposed date for that. There are 5 motions in this CAR that are to be voted on in late April by the Delegates of each respected Region in Narcotics Anonymous from around the world. Attending this workshop will help GSRs to better understand what the motions are about so that they can bring this information back to their home groups for a vote.
 - The first 3 motions are in regards to extending certain WSC Rules and Service Positions due to the pandemic,
 - motion 4 is about a new piece of literature "Spiritual Principle A Day" book,
 - motion 5 is to approve the NAWS budget for this year.


