The Brattleboro Ad-Hoc Committee had a flyer hanging day on January 21st and have had several newcomers over the past month.


We discussed as a group and with PR about creating a flyer that is accessible for people who don't have a phone.


The Ad-Hoc is interested in facilitating a group activity within the coming months. We plan on having another Flyer hanging day in March but we will set a date at the meeting next week.




We also have been discussing our Policy and are getting a lot accomplished to that end.

We have tried to contact the Live Free Recovery House in Keene to determine potential times/days to start hosting an H&I presentation there again. No one has responded to us yet.


We are still in need of support. We plan to utilize the GMANA Facebook page to announce H&I information and connect with potential speakers. Be on the lookout for this in the near future!



I propose we sell the overstocked Basic Text for \$11 while supply lasts.




Our web administrator has researched Go Daddy website provider to get some basic costs. There is much work to be done, but approximate costs look like \$250 per year.






