MOTION 3: TO TEMPORARILY SUSPEND POLICY TO MAKE THE RD AND RDA TERMS FOR THREE (3) YEARS.

INTENT: At the World Service Conference (WSC), 2023 the WSC Cycle was temporarily made into a three (3) year cycle until 2029. Therefore, the current cycle will be from 2023 until 2026 when the next live WSC will take place. All world level trusted servant terms were temporarily extended. Our current policy reads: "RD and RDA shall be two (2) year terms to coincide with the World Service Conference Cycle." Therefore, the intent was to have the terms coincide with the WSC Cycle. This motion was made with the unanimous consensus of those in attendance at the October Regional Service meeting.
