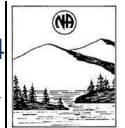


NEZF. ABCD now uses many services of the NEZF. We participate in the PR functions, events and meetings and benefit from the ESH of PR chairs and H&I chairs from around the NEZF. Through Fellowship Development (FD), we are developing a new website for the Region that will be able to host the member areas websites as a cost savings to the Areas. FD has assisted ABCD in our planning session, in workshops, getting us on the BMLT so we can use the app and connect our meeting schedules directly to one location to avoid duplicitous editing, getting us the YAP software so our Helpline is linked to our meeting schedule, and other assistance. NEZF estimates that they will be able to fully fund their service eAorts if each member Region contributes \$716 annually so we should contribute our fair share. Region has the funds and would like to use them for this purpose with the permission of the Areas. This is a 90 day motion and will be voted on in March.

There is Still Hope meeting (Noon Thursdays) needs support.

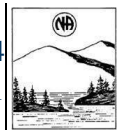

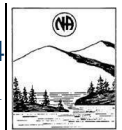

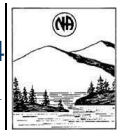
