The H&I subcommittee met today with nine participants! We had another new participant join today, which makes back-to-back months of new folks becoming involved! We are excited for greater support!

We have hosted three meetings at the Cheshire County House of Corrections facility (CCHOC) during the month of April. Our meeting for the mens D-Pod was held on Thursday, 10-Apr-2025. We had three attendees join. We gave out one six month keytag and proceeded to read Tradition Three from the Basic Text. All participants shared and highlighted some of the challenges they encounter while being incarcerated. They are eager to leave the facility and attend NA meetings.

We again encouraged them to attend an NA meeting as soon as they leave. We hope to see them at an outside meeting in the near future. Thank you to Bob C., Joseph R. and Josh R. for their service.

We hosted a meeting for the Women's pod on Friday, 18-Apr-2025. Two attendees joined. We gave out a 30 day and 90 day keytag and read 'Who Is An Addict' from the Basic Text. The two attendees were highly interested in learning more about NA and requested to borrow two basic texts. We gladly obliged. We hope to see them again next month! The April meeting for the mens K-Pod was held on Tuesday, 22-Apr-2025. We had two attendees and began the meeting with a discussion on Sponsorship. We then continued with reading 'What Can I Do' from the Basic Text. There was further sharing on the reading from both attendees. Thank you to Jake O. and Les T. for their Service!

Our postponed H&I Learning Day was held on Saturday, April 12th at the Turning Point facility in White River Junction, VT. The event started at 12:00 P.M. and we closed the presentation around 3:30 P.M. We saw 16 participants in person during the day and two Zoom attendees. One of the attendees on zoom was from Northern Canada! The event was a success and we held important discussions on H&I Do's and Don'ts, challenges H&I subcommittees face and the importance of referring to our H&I policies and H&I literature. Thank you to everyone who supported the event!

Our budget balance was at \$591.27 at the beginning of April. However, we spent \$177.26 on food for the H&I Learning Day. Our new current balance is \$414.01.

We held brief discussions today surrounding potential new H&I commitments at the Brattleboro Retreat in Brattleboro, VT, Avenues Treatment Facility in Dublin, NH and the Marble Valley Regional Department of Corrections in Rutland, VT. We plan to contact the Retreat and Avenues within the next month to learn of their interest for us to host H&I commitments. We are aiming to contact the Rutland prison towards the end of the summer (August) as folks' schedules open up. More will be revealed on these topics, but we continue to make progress within our sub-committee and encourage other to join in the success! Addicts in need of hearing our life saving message could benefit from your involvement!
