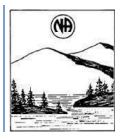

January 2026 ASC minutes were read and approved.



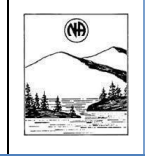

RCM Alt			Section 7.13 Regional Committee Member Alternate The recommendations for RCM- Alt are the same as RCMwith the exception of two years clean.

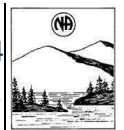

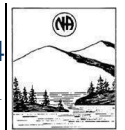
